

TBZ-The Original signs First Franchise Agreement for its upcoming store in Dhanbad

This will help in adding incremental sales, expanding retailing space and enhancing pan-India presence of TBZ-The Original.

According to Mr Shrikant Zaveri, Chairman and Managing Director, TBZ Limited, *"Every franchisee store will offer a wide array of innovative and attractive jewellery designs with an added attraction of custom-made products. They will showcase a vast range of contemporary and modern jewellery collection and a mix of gold, diamond and precious stones studded jewellery for discerning customers. They will provide the same standardised shopping experience to customers, as company owned stores. We will handhold our franchisee partners in the initial stages to take them through the learning curve of doing business with us and serving customers the TBZ-The Original way. We intend to pace ourselves comfortably through the process to ensure we do not compromise in the quality of TBZ-The Original experience."*

With this new business strategy, TBZ-The Original will remain focussed on growth and expansion over coming years. Going forward, the store expansion will be through a right mix of company-owned and franchisee stores, helping the company to achieve its target of growing its retail space from current 93,000 sq ft to around 1,50,000 sq ft over coming 2-3 years.


