8 KILLED, OVER 4 LAKH HIT BY PRE-MONSOON FLOODS IN ASSAM

FLOOD, LANDSLIDES WREAK HAVOC IN NORTH-EAST

GUWAHATI/ITANAGAR/AGARTALA

With one more people dead in Udalguri district, the death toll rose to eight in the ongoing pre-monsoon floods and landslides in Assam, where over four lakh people have been affected in 26 districts so far, a government bulletin said on Tuesday.

Landslides triggered by incessant rain snapped rail and road links to Barak Valley and Dima Hasao district of Assam and neighbouring states of Tripura, Mizoram and Ma-

Landslides wreaked havoc in Arunachal Pradesh and Meghalaya also snapping road connectivity in many ar-

eas. An Assam State Disaster Management Authority (ASD-MA) bulletin said the number of affected people has reached 4,03,352 across 26 districts

Union home minister Amit Shah has assured Assam of all assistance from the Central government even as the state administration has been pursuing measures to ensure the supply of essential commodities to the affected areas and restore communication channels.

"Concerned about the situation in the wake of heavy rainfall in parts of Assam. Spoke to CM Shri @himantabiswa to take stock of the situation. NDRF teams are already been deployed. Assured all possible help from the central government," Shah Tweeted on Tuesday evening.

On May 5, the National **Commission for Protection** of Child Rights had sought action against Kamra for

tweeting the "doctored" video. The Commission has now asked Director, Twitter Communications India, to appear on Wednesday with the details of the action taken report.

"A letter in this regard was sent to your good offices dated 05.05.2022 calling for an ATR (action taken report) in the instant complaint within 7 days or receipt of the letter. "However, no such ATR

has been yet received by the Commission," the NCPCR said in the letter sent on Tuesday.

Jet Airways completes key test, awaits final flying permit

NEW DELHI

Jet Airways has successfully operated all proving flights and is now looking forward to the grant of air operator certificate (AOC) by aviation regulator DGCA, its owner Jalan-Kalrock Consortium said on Tuesday. The airline conducted the second -- and the last -- set of two proving flights on Tuesday with 31 people, including officials of the Directorate General of Civil Aviation (DGCA) on board, sources said.

The carrier had on Sunday conducted the first set of three proving flights with 18 people, including the DGCA officials on board, they said. Proving flights is the last step for the airline to obtain the AOC. A total of five landings (five flights) have to be done by the aircraft to successfully complete its proving flights.

In a statement on Tuesday, the spokesperson of Jalan-Kalrock Consortium stated, "We have successfully conducted our proving flights over two days, and we now look forward to the grant of the AOC by the DGCA." The two proving flights on Tuesday were conducted on Delhi-Hyderabad



and Hyderabad-Delhi routes using the carrier's Boeing 737 plane, sources said.

The three proving flights that were conducted on Sunday were on Delhi-Mumbai, Mumbai-Ahmedabad, Ahmedabad-Delhi routes using the same plane, they noted. Jet Airways had on May 5 conducted its test flight to and from Hyderabad in a step towards obtaining the AOC.

The airline in its old avatar was owned by Naresh Goyal and had operated its last flight on April 17, 2019. The Jalan-Kalrock Consortium is currently the promoter of Jet Airways.
